## Amendments in the Administrative Functions Disposal Authority (AFDA) 2010 edition

The following table lists the amendments that have been made to the August 2000 edition of AFDA. It includes the corresponding class in the AFDA 2010 edition and whether there is a need to resentence the records.

The RESENTENCE column will indicate whether a record needs to be resentenced as a consequence of the revisions. In some cases the need to resentence will depend on the type of revision made to the affected class.

For example, contract classes where the class is now dependent on the date of the contract; or where a class has been cancelled and replaced by multiple classes. Records previously covered by the revised classes will require review to determine if their retention period needs to be amended to comply with new requirements. These classes have been indicated in the table by the notation "Review."
