> NORTHERN TERRITORY OF AUSTRALIA. PROCLAMATION

Commonwealth of Australia to wit. W. J. MCKELL Governor-General.

By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS by virtue of section one hundred and three of the Crown Lands Ordinance 1931-1948, it is provided, amongst other things, that the Governor-General may, at any time, by Proclamation, reserve for any public purpose which he thinks fit, any unalienated Crown lands not subject to any right, of, or contract for, purchase:

And whereas it is desirable to reserve for the purpose of a quarantine paddock for live-stock the lands described in the Schedule hereto being Crown lands which are unalienated and not subject to any right of, or contract for, purchase:

Now, therefore, I, William John McKell, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby reserve for the purpose of a quarantine paddock for live-stock the Crown lands described in the Schedule hereto and declare that the lands so reserved be known as the Alice Springs Quarantine Reserve.

THE SCHEDULE.

All that piece or parcel of land adjacent to the town of Alice Springs in the Northern Territory of Australia, containing an area of approximately 12 square miles, and more particularly described as follows:

Commencing at a point where a northern boundary of Pastoral Lease No. 118A intersects the western side of the Alice Springs-Port Augusta Railway Reserve thence westerly along the aforementioned northern boundary of Pastoral Lease No. 118A for 45247 links to an eastern boundary of Pastoral Lease No. 118A thence northerly along the said eastern boundary for about 180 chains to its intersection with the western prolongation of a range of hills thence easterly along the said western weatern and the said the said the said the said the said the said the same time to be about the said the same time to be about the said the same time to be about the same time time to be a western prolongation generally easterly along the summit of the range of hills and easterly along the eastern prolongation of the said range of hills for a total distance of about 5 miles 10 chains to the western side of the Alice Springs-Port Augusta Railway Reserve thence south southeasterly along the western side of the said Railway Reserve for about 2 miles 45 chains to the point of commencement.

This area does not include a reservation of half a chain on each side of the overland Telegraph Line and a road half a chain each side of the centre line of the road to Henbury.-(D.I. 49/119.)

ORDER

Commonwealth of Australia to wit. W. J. MCKELL Governor-General.

WILLIAM JOHN MCKELL, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby order that section 63 of the Lands Acquisition Act 1906-1936, insofar as it relates to the disposal to private industry of land acquired or used by the Common-wealth in connexion with the defence of the Commonwealth, in addition to the Acts at present administered by the Minister of State for Post-war Reconstruction, shall be administered by the Minister of State for Post-war Reconstruction.
