  - (f) the office of The Secretary to the Department of the Navy
  - (g) the office of The Secretary to the Department of Transport
  - (h) the office of The Director-General of Works
- (3) the abolition, in pursuance of the Public Service Act 1922–1973, of all Second, Third and Fourth Division offices in the Departments specified in (1) above.
- (4) change of the name of The Department of Works to The Department of Housing and Construction.
- (5) the creation, in pursuance of the Public Service Act 1922–1973, of each office specified in the first column hereunder to be the Permanent Head of the Department opposite to the name of that office in the second column hereunder—
