ADMINISTRATIVE ARRANGEMENTS

ORDERED BY HIS EXCELLENCY THE GOVERNOR-GENERAL

- I, SIR JOHN ROBERT KERR, the Governor-General of Australia, acting with the advice of the Executive Council, hereby approve the following administrative arrangements in substitution for the arrangements in operation immediately before the date of this Order:
