ADMINISTRATIVE ARRANGEMENTS

ORDERED BY HIS EXCELLENCY THE GOVERNOR-GENERAL

- I, SIR JOHN ROBERT KERR, the Governor-General of Australia acting with the advice of the Executive Council-
 - (a) hereby approve the following administrative arrangements:
 - the matters dealt with by the Minister of State for Manufacturing Industry include the following matter, namely, Adjustment assistance to industry;
 - (ii) the enactments administered by the Minister of State for Overseas Trade no longer include the Australian Industry Development Corporation Act 1970-1973 and the matters dealt with by the Department of Overseas Trade no longer include matters arising under that Act and the following matter, namely, Adjustment assistance to industry;
 - (iii) the enactments administered by the Prime Minister no longer include the Industries Assistance Commission Act 1973 and the Prices Justification Act 1973-1974 and the matters dealt with by the Department of the Prime Minister and Cabinet no longer include matters arising under those Acts;
 - (iv) the enactments administered by the Special Minister of State include the Industries Assistance Commission Act 1973 and the Prices Justification Act 1973-1974 and the matters dealt with by the Department of the Special Minister of State include matters arising under those Acts; and
 - (v) the enactments administered by the Treasurer include the Australian Industry Development Corporation Act 1970-1973 and the matters dealt with by the Department of the Treasury include matters arising under that Act; and
 - (b) hereby approve the continuation in force of the administrative arrangements set out in the Administrative Arrangements Order made on 1 October 1974 except in relation to the enactments and matters referred to in paragraph (a).
