ADMINISTRATIVE ARRANGEMENTS

ORDERED BY HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT OF AUSTRALIA

- I, SIR ARTHUR RODEN CUTLER, the Administrator of the Government of Australia, acting with the advice of the Executive Council—
 - (a) hereby approve the following administrative arrangements:
 - (i) the enactments administered by the Minister of State for Labor and Immigration no longer include the Passports Act 1938-1973 and the matters dealt with by the Department of Labor and Immigration no longer include matters arising under that Act; and
 - (ii) the enactments administered by the Minister of State for Foreign Affairs include the Passports Act 1938-1973 and the matters dealt with by the Department of Foreign Affairs include matters arising under that Act; and
 - (b) hereby approve the continuation in force of the administrative arrangements set out in the Administrative Arrangements Orders made on 8 February 1975 and 28 February 1975 except in relation to the enactments and matters referred to in paragraph (a).
