ADMINISTRATIVE ARRANGEMENTS
ORDERED BY HIS EXCELLENCY THE
GOVERNOR-GENERAL

I, SIR JOHN ROBERT KERR, the Governor-General of Australia, acting with the advice of the Executive Council--

- (a) hereby approve the following Administrative Arrangements:
 - (i) the matters dealt with by the Department of Administrative Services include the following matters:

Australian Government purchasing policy Procurement and purchase of goods and services, as required, for Australian Government purposes Maintenance of stocks of any such goods Disposal of surplus goods; and

(ii) the matters dealt with by the Department of Manufacturing Industry no longer include the following matters:

Australian Government purchasing policy Procurement and purchase of goods and services, as required, for Australian Government purposes Maintenance of stocks of any such goods Disposal of surplus goods; and

(b) hereby approve the continuation in force of the Administrative Arrangements set out in the Administrative Arrangements Orders made on 1 July 1975, 26 September 1975, 7 October 1975, 14 October 1975 and 30 October 1975 subject to the changes made by this Order.
