ADMINISTRATIVE ARRANGEMENTS ORDERED

BY HIS EXCELLENCY THE GOVERNOR-GENERAL

- I, WILLIAM GEORGE HAYDEN, Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby make the following changes to the administrative arrangements set out in the Administrative Arrangements Order notified in the Gazette of 3 July 1990:
- (a) amend the first column of the Schedule to the Order by deleting the reference to 'The Department of Community Services and Health' and substituting 'The Department of Health, Housing and Community Services';
- (b) amend the second column of the Schedule to the Order under principal matters dealt with by the Department of Health, Housing and Community Services by deleting the reference to 'Housing assistance' and substituting 'Housing';
- (c) amend the second column of the Schedule to the Order under principal matters dealt with by the Department of Industry, Technology and Commerce by deleting the reference to 'Building industry' and substituting 'Construction industry (excluding residential construction)'.
