ADMINISTRATIVE ARRANGEMENTS ORDERED BY HIS EXCELLENCY THE COVERNOR-GENERAL

I, WILLIAM GEORGE HAYDEN, Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive or Australia, secting with the sollowing changes to the Council, hereby approve the rollowing changes to the administrative arrangements set out in the Administrative Arrangements Order made on 27 June 1990, and amended on 7 June 1991 and 29 October 1991, to take effect on 27 December 1991;

- (a) amend the first column of the Schedule to the Order by deleting the reference to 'The Department of the Arts, Eport, the Environment, Tourism and Territories' and substituting 'The Department of the Arts, Sport, the Environment and Territories': Environment and Territories;
- (b) amend the first column of the Schedule to the Order by adding a reference to the 'Department of Tourism';
- (c) amend the second column of the Schedule to the Order under amend the second column of the Schedule to the Order under principal matters dealt with by the Department of the Arts, principal matters dealt with by the Department of the Arts, principal matters and Territories by deleting the Sport, the Environment and Territories by deleting the reference to 'Tourism, including the tourist industry' and 'International expositions and support for international conferences and special events': conferences and special events';

- (e) in the third column of the Schedule to the Order, the enactments administered by the Ministers of State enactments commissioned by the ministers of state administering the Department of the Arts, Sport, the againistering the Department of the Arts, aport, the Environment and Territories no longer include the Environment and Territories no longer include the Australian Australian Tourist Commission Act 1987 and the Australian Tourist Commission (Transitional Provisions) Act 1987; and Tourist Commission (Transitional Provisions)
- (f) in the third column of the Schedule to the Order, the ensetments administered by the Ministers of State enactments administered by the ministers of State administering the Department of Tourism are the Australian Tourist Commission Act 1987 and the Australian Tourist Commission (Transitional Provisions) Act 1987.
