The National Archives of Australia 2022–25 Data and Digital Strategic Direction sets our transformation journey over the next four years.



The National Archives of Australia continues to respond to evolving priorities in the information environment. We are guiding Australian Government agencies towards a comprehensive information management capability in this context. This guidance is set out under our new whole-of-government policy *Building trust in the public record: managing information and data for government and community.*

Our mission is to connect Australians with their identity and history through our stewardship of Australian Government records.


Information and technology plays an increasingly critical role

in retaining the memory of our nation. Growth across government information and data is increasing exponentially, driven by digitisation and increased public engagement through digital channels.

Our Data and Digital (D&D) strategy guides technology adoption and implementation as we deliver of our mission to connect Australians with their identity and history through our stewardship of Australian Government records.

The D&D strategy builds on the previous strategy, addressing the need for enhanced capability to preserve the collection and the rapid growth in digital information generation.

To enable our vision and mission, our D&D strategy focuses on three themes.







Innovation and emerging technologies provide context for our D&D strategy as we introduce new capabilities to preserve our collection in perpetuity. The innovation driven by rapid advances in technology necessitates that we transact digitally with our government partners and the public.

Our D&D strategy presents a customer-focused approach to deliver enhanced digital channels; contemporary data capture; processing and visualisation; use of artificial intelligence for complex decision-making; increased cyber resilience; and use of transformational D&D capabilities.

My priorities, as Chief Information Officer and Chief Information Security Officer, are:

- customer access, enabled by richer experience with a range of new and uplifted digital capabilities
- archival capabilities to increase value generation, building on the foundational capabilities currently underway
- improvements to ways of working, by creating a modern workspace environment and using technology to enable seamless remote working
- further strengthening cyber resilience of the National Archives' environment.


Executive summary

Our vision for the National Archives: Australia's cultural identity and democracy is strengthened through connecting people with the evidence of Australian Government activities and decisions.

Our D&D strategy is aligned with our business vision, mission and strategies. It builds upon our D&D strategy for 2019–22, incorporating emerging needs and technologies for accelerated delivery of our mission.

Enabling the vision, our D&D strategy is focused on six business focus areas, which are distilled into three themes (Figure 1).

Data and digital strategy

Our D&D strategy identifies outcomes that will support the successful delivery of the National Archives' vision and mission. These outcomes relate to six business focus areas that feed into the National Archives' strategic direction through the overarching goals of our mission.

The National Archives' strategic direction steers us towards those overarching goals (Figure 3). It sets out our organisation's fundamental capabilities:

- We strive for excellent service as we make the collection available to the public while taking proper account of privacy, security, confidentiality and public interest.
- Our staff are equipped with the contemporary skills and competencies to work with digital tools and resources to deliver new services to the Australian Government and the general public.
- We will provide leadership in best-practice management of the official record of the Australian Government and ensure that information of enduring significance is secured, preserved and available.

The D&D strategic direction supports the overarching goals and organisational capabilities fundamental to the National Archives' strategic direction.

Business focus areas

Six business focus areas in the D&D strategic direction underpin our capacity to lead and innovate in the digital age.

Our six business focus areas are:

- contemporary archival services
- lead information governance, policy and practice
- an agile and mobile workforce
- a cyber security resilient organisation
- digital engagement enabled by platforms, data and insights
- contemporary and reliable D&D capabilities.

These business focus areas are detailed under 'Realising the future state'.

Outcomes

Specific technology goals inform the strategic outcomes we strive to deliver.

Technology goals

- The Australian public are able to easily, securely and reliably engage with and access the information held within the archives through their channel of choice.
- Our staff are provided the technology, tools and processes to support them as a professional workforce and be a world leading archive.
- Records and information exchanged with Government departments, stakeholders, and the
 public will meet the Australian Security Directorate requirements, providing safeguards for
 data privacy and security.
- We will lead and drive creativity and innovation through technology.

Strategic outcomes of technology goals

The technology goals we pursue under the D&D strategic direction will engender tangible outcomes. These strategic outcomes are to:

- preserve and secure the national archival collection
- put in place information and technology that underpin a world-leading digital archive
- enable modern and customer-focused information and technology services.

Essential D&D elements will factor into the achievement of each outcome (Figure 4).





Figure 7: Building blocks plotted over a four-year period, comprising three horizons




The role of data and digital

As we move towards our future state, the role of Data and Digital (D&D) will shift from being a business enabler to partnering with business areas to deliver services that provide maximum value.

Figure 8 shows that the current role of D&D is to maintain systems and infrastructure and act as an internal service provider. The future role of the National Archives' D&D function will be to:

- act as a service integrator
- support our business areas with sourcing and managing the best solutions available
- advise our business areas on all information and technology matters.
