The Sym Choon Family: Success Against the Odds of the White Australia Policy

Abstract:

Despite Australia's modern multicultural society, there are periods in our history of oppression on the basis of culture. The Sym Choon family's significance in overcoming the barriers of racism and the White Australia Policy, cannot be denied. The use of primary sources allows critical thinking and understanding of their legacy.

“Every voice raised against racism chips away at its power. We can't afford to stay silent.” Reni Eddo-Lodge: Why I'm No Longer Talking to White People About Race.¹

The Sym Choon family were among the first of these said ‘voices’ in South Australia.

Present-day Australia has embraced multiculturalism by following a method of integrating different ethnicities. Yet, for the majority of the nation’s early history, a racist view of society drove immigration policies, and limited immigrants to those who qualified under the White Australia Policy.

Six separate British colonies joined in 1901 to form Australia – following the footsteps of the anti-Chinese legislation in response to the Gold Rush immigrants, securing a ‘white’ Australia was priority for the newly federated country and government.^{2 3}

Thus, the Immigration Restriction Act 1901, also known as the White Australia Policy, became one of the first Commonwealth Laws passed subsequent to Federation. Its purpose was restricting non-white immigration to Australia. Prospective migrants were required to succeed the dictation test, consisting of fifty words in any European language – this enabled immigration officers to exclude those not of preferable origin, without being explicit.^{4 5}

All ‘non-white’ people previously residing in Australia were required to apply for a Certificate of Exemption from the Dictation Test (C.E.D.T.), permitting them to leave and re-enter Australia without being subjected to it. Each member of the Sym Choon family were obliged to apply for this during the 1920s, when they travelled to and from China and Hong Kong on business.⁶

With an adopted first name, 'John' Sym Choon is an early example of chain migration. Having arrived in Australia in the early 1890s, and settled in Unley, Adelaide, he began a career as a hawker, purchasing produce from the East End markets and using his handcart to sell it door-to-door. With the money he gathered over eight years, Sym Choon was able to transport his wife, So Yung Moon, whom he married in 1888, from Dongguan, southern China, to Adelaide.^{7 8 9} Accordingly, Sym Choon played a substantial role in family reunification.

Together, while residing in Rundle Street, they initiated a business – *Sym Choon & Co.* – which became a successful supplier of fruits, vegetables, nuts, and fireworks. These humble beginnings were the first steps leading to generations of entrepreneurial pioneers in the Sym Choon family.^{10 11}

The five Sym Choon children had opportunities from an early age to pursue a career in commerce. For instance, in 1921, 'John' Sym Choon applied for C.E.D.T. in order to travel to Hong Kong for business purposes, over a duration of twelve months. He had two children he was 'desirous of taking home to China with him, namely Gladys Sym Choon... Robert Kitchner General Gordon Gum Foy ['Gordon'] Sym Choon'. However, it was necessary to submit compulsory materials such as character references, providing evidence of one's 'credibility'.^{12 13}

The said references were largely positive concerning the Sym Choons. Statements regarding 'John' affirmed he was 'a desirable citizen', as well as being 'of good character and [a] reliable man of business'. Additionally, Gladys had evidently excelled academically throughout her education, being 'an extremely bright student, much above the average in intelligence... her progress has been most

creditable'. Gordon Sym Choon, again, was confirmed to be a 'well-known ...bright' young man.^{14 15}

Clearly, despite restrictions rooted in discrimination, the Sym Choon family thrived, being exempt from the White Australia Policy's Dictation Test, generating their own momentous history.

Two Sym Choon brothers, George and Gordon, were profitable businesspersons in their own right. Although they engaged in a somewhat public feud, over a woman of Chinese descent from Western Australia that So Yung Moon arranged for George to marry, nonetheless with whom Gordon eloped, they were respected businessmen.¹⁸ Both ran lucrative businesses – that were, interestingly, rivals – and established 'reputations' in the community.

Gladys and Dorothy Sym Choon were women of Chinese descent in mid-1900s Australia. Hence, they found themselves in a disadvantaged position in society. However, they faced these challenges with indisputable courage and tenacity.

In 1926, Gladys, along with Dorothy, founded *The China Gift Store*. They used their Chinese heritage to their advantage – selling imported products from China, including napery, embroidery, and ornamental china. It resulted in instant success. To this day, the shop remains an Adelaide icon, reopened by Joff Chappel and his partner Razak Mohammed as a contemporary fashion boutique. Named *Miss Gladys Sym Choon*, it preserves its initiator's historical contributions as a female of foreign culture.¹⁹

The White Australia Policy impacted Gladys and Dorothy considerably through constantly meeting immigration officials' demands and unnecessary processes when re-entering Australia. Despite being born in Australia, they were required to undergo applications for the C.E.D.T. Dorothy Sym Choon, in particular, was outspoken with her opinions regarding this matter.

In 1923, Dorothy and So Sung Moon, her mother, intended to leave 'Adelaide by train about 24th February 1923' and proceed 'overland to embark on the S.S. 'ST. ALBANS' at Melbourne for China 1/3/23'. Dorothy's submitted passport, mandatory for the C.E.D.T., entailed information details such as her profession and physical appearance. She and her mother were additionally instructed to imprint their left and right thumb impressions. Dorothy 'objected to having her thumb prints taken and did not anticipate any trouble whatever as she was well known in Sydney and Melbourne'. This event reflects her personal resolve and significance in confronting prejudice. Additionally, their exemption demonstrates that occasionally, economic 'success', assisted in overcoming the discrimination-based bureaucracy in that time. Through their commercial 'significance', they challenged the White Australia Policy effectively.^{20 21 22}

The last vestiges of the Act came to its conclusion in around 1973. The Sym Choon family story is significant, and is relevant historically in challenging discrimination and bureaucracy. This is reflected in the Sym Choon family's feature in a 2018 Adelaide Migration Museum exhibition, and the inclusion of Dorothy's portrait in artist Peter Drew's 2017 'Aussie Poster' series.^{23 24} The Sym Choon family's success is noteworthy, in leaving a legacy that continues to 'matter' today.

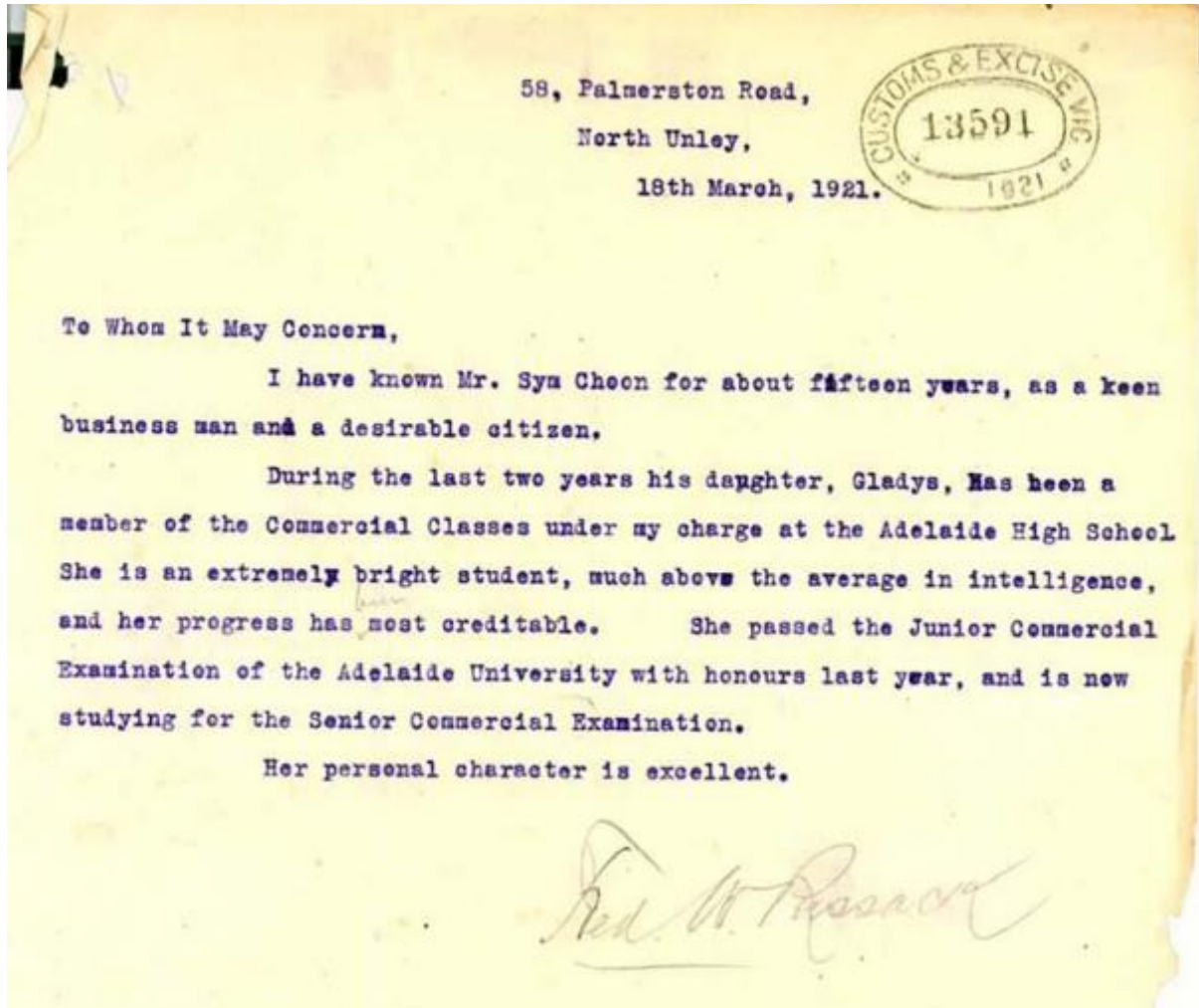

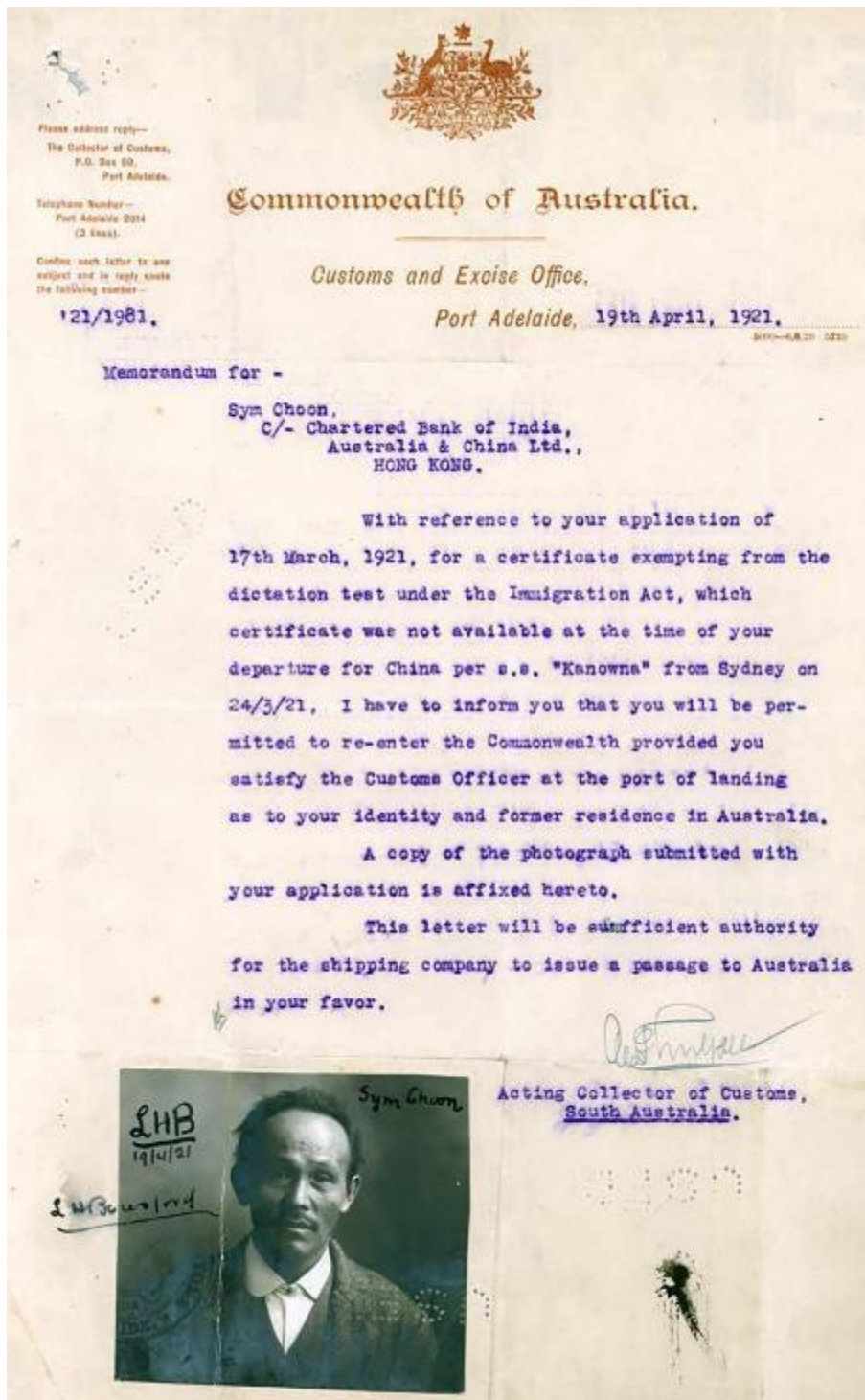

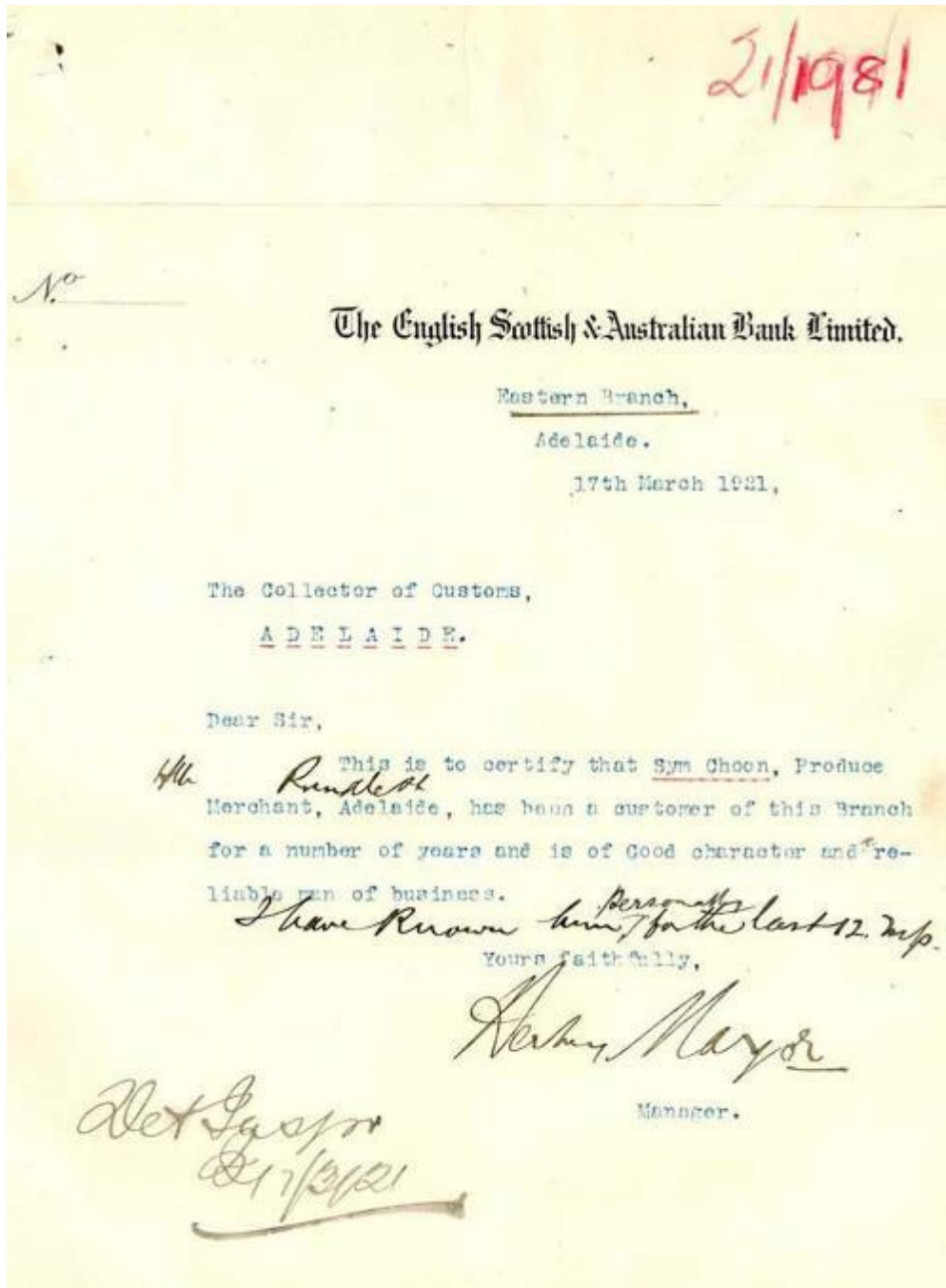
